7) School Reports

- a) Bellarmine University – finished up student staff selection (80 applications) and will be doing reveal party for placements soon; hired new operations person, Colleen Donovan-Arnett; currently hiring a Residence Life Coordinator position, a Director of Identity & Inclusion, adding an Assistant Director to that space, and a Director of Service & Leadership; campus is moving to a system-wide overhaul of language; has been charged with being fiscally responsible to manage budgets; currently completing an 18-month strategic planning process; finished SACS CLC 10-year re-accreditation process; this year's QEP is Inclusivity through Community Engagement

- b) Centre College – Record number of RA applications (82); had current RAs re-apply for their position for the first time; completing campus master plan that include new residential facility (hope to break ground by the end of the year); Vice President for Student Affairs was honored as a Hall of Fame honoree by CPAK; at full staff and hiring a Coordinator for next year; working with Diversity office to implement a bias reporting system
- c) Eastern Kentucky University – completing some strategic planning during budget cut discussions; Lisa Mendenhall chaired ACUHO-I Academic Initiatives Conference; currently hiring for Assistant Director for Training & Staff Development and Graduate Hall Director positions; record number of RA applications (280) and current RAs returning for next year
- d) Morehead State University – Housing Office has transitioned to another building; conducting search for Hall Director position
- e) Spalding University – As of December, has been at capacity; Residence Life Coordinator position opening in June; started to build ideas to create an Intramural program for campus
- f) Transylvania University – Closing largest first-year student residence hall and opening new residence halls; hired 4 new graduate Area Coordinators; recently sent out offer letters to RAs
- g) Western Kentucky University – Hilltopper Hall (newest residence hall) will open in the summer; engaged architectural firm to start planning for freshman village as part of master plan; currently hiring for several live-in positions, Living-Learning Coordinator, and new Assistant Director for Student Success position
- h) University of the Cumberlands – Dean of Student Life retired and has had an interim dean; has been making the transition from paper documents to digital documents; updating and reviewing RA expectations and experience

KAHO Constitution Review Committee Recommendations

Chaired by: Dr. Anthony White, President-Elect

- Develop and add KAHO Mission, Vision, and Values (see SEAHO Constitution). This will help define who we are, what we are, and what we stand for as an organization
- Split the Treasurer and Secretary into two respective positions. This will provide more opportunity for representation on the executive board and allow the secretary to focus on correspondence and bridging the gap between member institutions.
- Strategic planning inclusion in the Bylaws (see SEAHO Constitution). We all know this is important but can be time consuming. Adding the cycle in the constitution will help to ensure it gets done and that the organization is always planning and preparing for what's ahead.
- Add at least one additional standing committee. As currently structured there are only 4 at large positions to serve on standing committees. The other spots are reserved for host committee or governing council members. This could help boost interest in the organization and serve as a stepping stone for exposure and potential governing council grooming.
- Under article V add SEAHO annual meeting and the state/commonwealth CHO meeting.
- Add revenues and expenditures as standalone article (see SEAHO Constitution). This can help add insight to how the organization operates financially. In this day and age the more transparent we can be about being wise stewards of monies the better.
